SEVENTY-FIFTH POST-CONFIRMATION STATUS REPORT

This Seventy-Fifth Post-Confirmation Status Report is filed in accordance with the Post Confirmation Order and Notice, dated February 13, 2007 (the "Effective Date"), in connection with the cases of the above-captioned reorganized debtors (collectively, the "Debtors"). Since the filing of the Seventy-Fourth Post-Confirmation Status Report on July 15, 2025 for Adelphia Communications Corporation ("Adelphia") and Certain of its Affiliated Debtors, describing the Debtors' progress subsequent to the confirmation of the First Modified Fifth Amended Joint Chapter 11 Plan for Adelphia Communications Corporation and Certain of its Affiliated Debtors, dated as of January 3, 2007, as Confirmed (the "Plan"), for each of the Debtors other than the JV Debtors' by the order dated January 5, 2007 (the "Confirmation Order"), the Debtors, as reorganized pursuant to the Plan, have taken the following steps, among others, in connection with consummation of the Plan:

- Filed the Adelphia Communications Corporation and Subsidiaries 2024 Federal and State tax returns.
- Announced on July 10, 2025, a \$16.4 million distribution to holders of allowed claims. The distribution had a record date of July 17, 2025, and was made on July 23, 2025.
- Assisted ACC Claims Holdings, LLC with a distribution of \$14.5 million to holders of Class A and Class B interests. The distribution was made on July 31, 2025.
- Continued efforts to maximize the value of remaining assets.

Capitalized terms used but not defined have the meanings ascribed to such terms in the Plan.

The JV Debtors are comprised of the following legal entities: Century-TCl California, L.P.; Century-TCl California Communications, L.P.; Century-TCl Distribution Company, LLC; Century-TCl Holdings, LLC; Parnassos Communications, L.P.; Parnassos Distribution Company I, LLC; Parnassos Distribution Company II, LLC; Parnassos Holdings, LLC; Western NY Calbevision, L.P. The Third Modified Fourth Amended Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code for the Century-TCl Debtors and Parnassos Debtors, dated as of June 28, 2006, was confirmed by order dated June 29, 2006.
